## Metro Urban Growth Boundary December Decision Fast Approaching

Well, it won't be long now before we know the decision by Metro regarding if Oregon City will be allowed to expand southward towards our little community.

As reported last month in the "Bulletin" Oregon City is eyeing not only land along Beaver Creek Road for its industrial needs, but is also looking at land that will include property south of the golf course and **more**.

The residents of Beaver Creek were first made aware of Oregon City's intentions regarding crossing Henrici Road and taking an additional 255 acres in their expansion at the September meeting of the CPO. This news was further discussed and brought to the public's attention at a meeting on October 22, 2002, at Clackamas Community College that was hosted by Metro. Citizens of the Beaver Creek community gave testimony regarding the expansion, but felt that the decision had already been made and that the meeting was just a formality to comply with Goal 1, that addresses Citizen involvement.

Norm Andreen, Co-Chair of the Beaver Creek CPO, went on record to say that information given to Metro earlier in the meeting by Gary Hewitt of the Oregon City Commission was inaccurate. He had stated that Oregon City was working with the Beaver Creek CPO on how the 255 acres south of Henrici Road would be developed. Mr. Andreen stated neither he or Chuck Lyons, Co-Chair, had any conversation with anyone from Oregon City regarding the development of the area in question. Mr. Andreen was then cut short in his comments by Rod Park of Metro.

Doug Neeley, Oregon City Commissioner, to his credit, did not vote for the expansion south of Henrici Road at the Oregon City Council meeting. He along with Derrick Beneville were the 2 dissenting votes on the motion.

Mr. Neeley is also a member of Metro's MPAC Committee (Metro Policy Advisory Committee). He stated in that body his concerns concerning the expansion. He went on record to abstain in the vote on the decision. The vote at MPAC in its recommendations to Metro was NOT to include land south of Henrici Road.

**“Beavercreek Oregon a History  
Through the Looking Glass”**

*This is Part VI of a series of articles on the history of the Beavercreek area. Written by Jack Watts, whose family were some of the early settlers of the community. This history is reprinted from his original manuscript that had until now never been published, by permission of Gordon Watts. We dedicate this series to a man and his love of the Beavercreek countryside who took the time to stop, look, listen and capture for all, his remembrances. The Editor.*

--- ROADS AND TRANSPORTATION (CONT.) ---

The "Cream Hauler" was indeed a rugged individual; he jolted over rough roads that were muddy in winter, dusty in summer, and miserable with wind, rain, heat, and cold in season. His route started in the Highland-Clarkes area coming through Beaver Creek and way points all the way to Clear Creek Creamery. The Cream Hauler had to have a good team of horses and equipment because he put in very long hours over very rugged terrain and most often returned home very late at night.

People walked great distances--to churches, to stores, to socials, to visit neighbors, to other entertainments, and even to Oregon City. If one were lucky, one might catch a ride. There were times on the return trip when someone with a team and lumber wagon who was returning home after delivering a load of lumber would invite one to jump on and ride home. The running gear of a lumber wagon was not the most comfortable seat as it jolted along the bumpy road. This was bound to leave a lasting impression.

We recall a time when Fred Hettman stopped at the store on a particularly bad night with a cold rain pouring and a bitter cold wind blowing a gale. It was automatic for store personnel to meet a customer as he drove up to see if there was anything wanted. Fred was dressed in oilskins with a lap robe wrapped around his legs and under the robe was a lighted lantern near his feet to try to keep himself warm. Inquiring if we could help, he told us he was supposed to pick up some item for a neighbor asking that it be brought out so that he would not have to disturb his cozy arrangement getting out as he still had several miles before getting home. And on arriving home he would still have to care for his horses --to feed and water them and bed them down.

These were truly "Horse and Buggy" days when everyone traveled by horse and buggy, or team and hack or wagon. This mode of travel had some advantages over the auto and especially so along rural roads because if one met another with a horse or a team it was the custom to pull along side each other for a chat with no worry about blocking the road. This provided an opportunity to run one's eye over the other fellow's horse and rig and be able to tell a lot more about the person than one could by looking over a person's car today. For starters, the horse wasn't bought on the installment plan, and no bank or finance company had anything to do with the deal. In running one's eye over the other man's horse and equipment, one could size up how well his animals were taken care of and also the condition of the harness.

It was not at all unusual, even for professional people,

to own a horse and buggy. They would, on occasion, take their families for a Sunday afternoon drive into the countryside, perhaps with no special destination in mind, and they were able to enjoy the scenery as they rode along or to pull into the shade for protection from the sun for a cool rest. All of this was done at a pace that no car could match for the appreciation of the surroundings. The family might also refresh themselves at a spring beside the road. Then, just as one could judge a man by his horse and equipment, it was also possible to size up the feminine side of a home by the family wash hanging on the clothes line as old dobbin trotted along.

Sugar came in 100-lb. interlined burlap bags, and the white lining was washed, bleached and used for dishtowels; and flour came in cotton bags branded "Howard's Best," "Triumph" and others, which in their after flour-container life became aprons, bloomers, etc. Well, the degree of whiteness and shapes and sizes of the garments - told whomever passed by the size and approximate ages of the family members; and it was easy to discern if there was a baby in the family by the line of flapping diapers. Though having been washed many times, almost all these garments and bed sheets still showed faded traces of the brand names of the products they originally contained, and often were still legible.

Some rather strange things happened in those horse and buggy days, such as the time we heard about two young men who drove a great distance to a social and

dance wearing their working clothes in the interest of saving time. There was no thought of causing any real disturbance when they arrived, but they looked pretty tough as they approached the ticket table, whereupon the cashier pushed their money back to them, making it clear that they were not wanted! They figured they had not come that far to be left out in the cold and vowed to get even with that crowd if it was the last thing they ever did.

Beyond the dance hall was the horse shed where the horses, still harnessed and hitched to their rigs, were tied. It didn't take these two fellows long to mix up the horses, hitching them to the wrong rigs, after which they were content to lurk in the shadows to await the break-up of the party. What a time these people had! And the horses itching to head home, some taking opposite directions to what the driver wanted to go, and if anyone caught on to the deception, and turned back to retrieve his own steed, there was no telling when, where or how it could be found. Even the next morning, what could they do? At the time there were no telephones and their problems became very complicated!

Reye's Syndrome should be suspected in anyone who vomits repeatedly. Phone your doctor immediately if these symptoms develop. Voice your concern about Reye's Syndrome. If your physician is unavailable, take the person to an Emergency Room promptly. Two liver function tests (SGOT, SGPT) can be done to determine the possibility of Reye's Syndrome. There is a 90% chance of recover when the syndrome is treated in its earliest stages by physicians and nurses experienced in the treatment of Reye's.

Studies have shown that using aspirin or aspirin-containing medications to treat the symptoms of viral illnesses increases the chance of developing Reye's Syndrome. **Reye's Syndrome**

Reye's Syndrome is a very serious disease that you should know about. Some people develop Reye's Syndrome as they are getting over a viral illness, such as the flu or chicken pox. Reye's Syndrome usually affects people from infancy through young adulthood; however, no age group is immune. Although Reye's generally occurs when someone is recovering from any viral illness, it can develop 3 to 5 days after the onset of the illness. Its main targets are the liver and brain, it is non contagious, and too often is misdiagnosed as encephalitis, meningitis, diabetes, poisoning, drug overdose, or sudden infant death.

Early diagnosis is crucial. An individual should be watched during the next 2 to 3 weeks following a viral illness for these symptoms, usually occurring in this order: Relentless or continuous vomiting, listlessness, drowsiness, personality change, disorientation or confusion, combativeness, delirium, convulsions, or loss of consciousness.

The Boosters will also be having their annual Christmas tree fundraiser beginning December 7th at the same location.

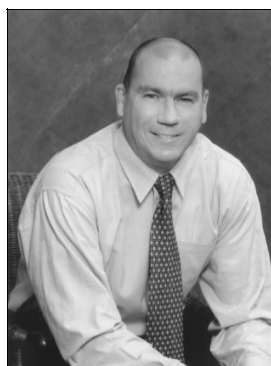

### Federal, State Officials Acknowledge Clackamas County For Its Efforts To Protect The Public From Natural Hazards

Officials from the Federal Emergency Management Agency (FEMA) and Oregon Emergency Management acknowledged Clackamas County on October 24 for its commitment to protect the public from natural hazards. The county is the first jurisdiction in the nation to meet new FEMA criteria for Natural Hazards Mitigation.

On September 19th, 2002, the Clackamas County Board of County Commissioners demonstrated the

County's commitment to public safety by adopting the Clackamas County Natural Hazards Mitigation Plan. By doing so, Clackamas County became the first jurisdiction in the nation to develop a mitigation plan that meets new Federal Emergency Management Agency criteria. The FEMA-approved mitigation plan increases the county's accessibility to hazard mitigation grant funds to implement mitigation measures designed to reduce the impact of natural hazards.

In recognition of the proactive planning efforts in Clackamas County, representatives from the local, state, and federal level presented the Board of County Commissioners with the official mitigation plan acceptance letter at a public hearing on October 24th. FEMA Region X Director, John E. Pennington, presented the official acceptance letter to the Board of County Commissioners.

"Clackamas County's Natural Hazards Mitigation Plan combines hard lessons-learned with innovative and sustainable actions that reduce vulnerability from future disasters," said Pennington. "The partnerships and policies that make this plan work can be easily duplicated by other communities, and we'd like to encourage the adoption of similar plans nation-wide."

Additionally, the Director of Oregon Emergency Management, Beverlee Venell, and the state Hazard Mitigation Officer, Dennis Sigrist, addressed the commissioners. The support of these state and federal representatives has assisted the local planning effort in Clackamas County, and will they will continue to provide direction for the county in meeting our mitigation planning goals.

"Clackamas County has taken steps to reduce risk and prevent loss from a variety of hazards by partnering with the University of Oregon's Natural Hazards Workgroup, to develop the Clackamas County Natural Hazards Mitigation Plan" said Venell. "The goal of the plan is to make Clackamas County a more disaster-resistant community by developing activities such as education, outreach, planning and community partnerships that can reduce or eliminate impacts resulting from natural hazards."

The Clackamas County mitigation planning effort directly supports the *Partners for Disaster Resistance: Oregon Showcase State* by making Oregon better prepared to minimize risk and impact of natural hazards.

The presentation occurred during the Board of Commissioners regularly scheduled meeting on Oct 24. The meeting was held in the Board's hearing room, 906 Main Street in Oregon City.
