## Flurry Of Activity Seen On Highway 213 Week of June 20th

The week of June 20th the contractor drove piling on the east side of Highway 213 by the 76 Gas Station (Stein Oil) to prepare the foundation for a new permanent sign across the highway. The work took place during the daytime behind the concrete traffic barrier on the east side of the highway. Although all Highway 213 travel lanes remained open during this daytime construction, a flagger was expected to occasionally direct traffic to allow trucks to enter and exit the work zone.

Also, the contractor moved a large crane into the project area. The crane is stored adjacent to the north side of Washington Street next to the site of the new Highway 213 bridge. Over the next several months, the contractor will be building the new Highway 213 bridge superstructure next to the highway, where its construction will have little to no interference with traffic.

## Health Reminder For State Park Visitors Traveling With Horses

Horses in Oregon and Washington have recently tested positive for a contagious virus, equine herpes virus-1, which can be fatal to horses. The virus does not pose a danger to people or other animals.

While the State Veterinarian in the Oregon Department of Agriculture has not issued a travel restriction for Oregon, campers and day visitors destined for State Parks to camp and ride on trails and beaches should ensure the health of their animals before they visit, and refresh their understanding of the symptoms of the neurological disease caused by the virus (equine herpesvirus myeloencephalopathy).

cal youth baseball and softball organization for kids. This building is located at Wesley Lynn Park in Oregon City. Three suspects broke into the building by cutting the padlock on the gate and then prying off the handle. Thieves have made several attempts to get into this building before.

Once they gained entry into the building they located an ATV used for field maintenance. They stole the ATV and pushed it through the park and onto Caddis Place. A homeowner on Caddis Place woke up when they heard the commotion and heard them trying to start the ATV. The homeowner called police. The suspects were apprehended by Oregon City Police moments later. All three suspects were lodged at the Clackamas County Jail for Burg II, UUMV, and Crim Misch II. The suspects are: Jeramie Thomas Scott, 19 yrs old, Oregon City resident; Douglas Michael Wing, 18 yrs old, Oregon City resident; Stephen W. Ragsdale, 19 yrs old, Oregon City resident. ## Dedication Scheduled For Vietnam Era Veterans Memorial

With the completion of the final statue, A Hero's Prayer, the Vietnam Era Veterans Memorial in Canby, Oregon is scheduled for dedication on August 6, 2011.

The Memorial, which honors all who served in the Vietnam Era, is thought to be the only "era" memorial in existence. The volunteers who came up with the idea for the memorial determined to focus on the courage and struggle of humanity caught up in war, and so the two main elements of the memorial plaza are a "Huey" Medevac helicopter provided on permanent loan from the US Department of Defense and the statue, "A Hero's Prayer".

The helicopter is mounted high above the plaza in a landing attitude about to rescue the three people represented by the statue: a soldier carrying a wounded buddy and accompanied by a young Vietnamese girl.

This project, a decade in the making, was headed up by the non-profit Vietnam Era Veterans Memorial Committee, and supported by a huge community of businesses, local governments and schools, and countless individuals who gave both time and money to bring the project to fruition. As word of the project spread over the years, the supporters came from farther and farther away, as it became evident that the memorial is more than a local attraction, but is actu-

ally of significance to anyone across the nation who served during that era or had family and friends serving during the Vietnam War years.

The dedication ceremony will be conducted by the Oregon National Guard. The guard is also providing some static displays of military vehicles. The Vietnam Era Veterans Memorial Committee will provide a reception after the military dedication ceremony. ## Waterfront Blues Festival July 4 Fireworks Largest Display In Oregon

The 2011 Safeway Waterfront Blues Festival, presented by First Tech Credit Union, will celebrate July 4th with a spectacular, display of fireworks, the largest display in Oregon. The Waterfront Blues Festival Fireworks Show starts at 10 p.m., after the evening's final performance and the National Anthem, performed by Linda Hornbuckle.

Admission to the 2011 Safeway Waterfront Blues Festival, including the fireworks show, is a donation of \$10 (or more) plus two cans (or more) of nonperishable food.

Oregon Food Bank produces the blues festival, including the fireworks display, to raise food and funds for people who are hungry in Oregon and Clark County, Wash. Due to continuing high unemployment, growing foreclosures and increasing food and gas costs, distribution of emergency food throughout Oregon and southwest Washington is at record levels.

Western Display Fireworks will fire the 2011 firework display from a barge on the Willamette River. Western Display choreographs the show to the tempo and intensity of a soundtrack produced and simulcast by KINK.fm 101.9.

As long as the Safeway Waterfront Blues Festival has had fireworks, Western Display Fireworks has produced the display with Bob Gobet, company owner, as the lead pyrotechnician. ## Family Loses Nearly Everything Including A Pet In A Fast Moving House Fire In Oregon City

On Tuesday evening at 5:41 p.m. May 24th, a neighbor next door to 143 Valley View Drive in Oregon City called to say his neighbors home was on fire with flames and smoke visible from the back of the home. The first engine company arrived within 5 minutes and found 20 foot flames coming from the back of the home, reaching up over the peak of the roof. They quickly went to work extinguishing the fire. It took only 25 minutes to bring this fire under control. Several more hours were spent cooling hot spots and checking for hidden fire. A crew stayed at the home overnight to make sure no possible hot spots started back up.

The residents were home at the time and were able to get outside safely before their home was destroyed by this fast moving fire. The residents said they were grilling chicken on their gas grill just moments before the fire started. They had just taken the food off of the grill and turned the grill off. The gas grill was positioned up against the house, under a covered patio.

Once inside their home they heard an explosion and saw the flames. They were able to make it outside through the front door. They grabbed 2 of their 4 dogs as they left. One was rescued by firefighters and is perfectly fine. The one dog that was sleeping on the bed in the back bedroom did not survive the heat and smoke.

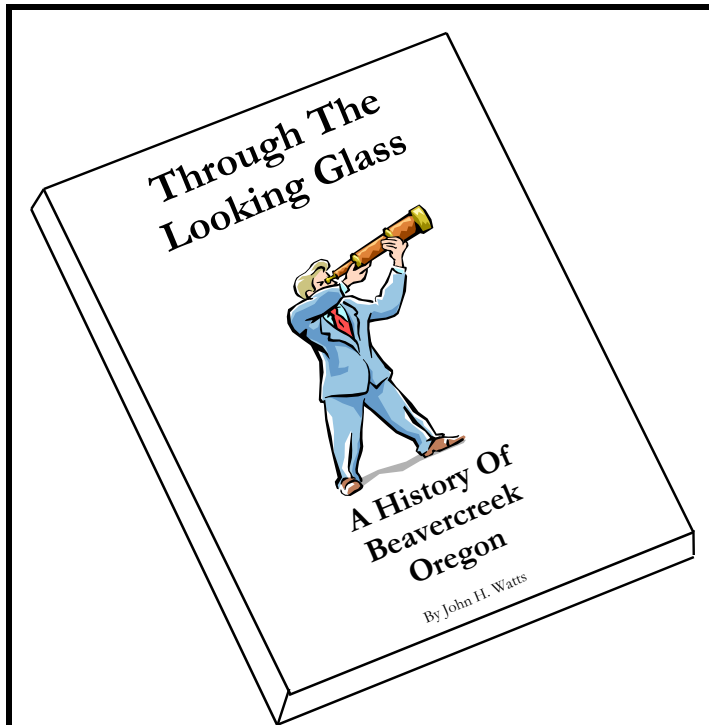
Investigators were on scene and able to determine the propane tank was the likely cause of this tragedy. No firefighters were injured and Clackamas Fire was assisted by Canby Fire and Tualatin Valley Fire & Rescue.

Homeowners were only able to retrieve some of their clothing after the fire was out. It appears the home and the rest of their belongings were destroyed by the fire, smoke and heat.

It is always recommended that grills of any type be placed at least 6 feet away from any structure or vegetation such as trees or shrubs. Also, once you are done grilling, turn off the gas on the grill AND the tank valve.

The vector species will be tested by CCVCD to determine if they carry West Nile virus. If a positive test occurs, the OSU Lab will be sent the sample for confirmation of West Nile virus. Once a positive occurs, the CDC and CCVCD will send notification to the partners and a news release will be generated. CCVCD will continue to keep its partners informed each week concerning the presence of vector species.

This year CCVCD will also be testing Jays and Crows (birds that belong to the Corvid family), Robins and Raptors for West Nile virus. Please call CCVCD at 503-655-8394 if you see one of these birds that has not been dead any

## Keep It Legal Keep It Safe

June 23, 2011, marked the opening of the season for fireworks sales in Oregon.

Legal fireworks may be purchased only from Oregon permitted fireworks retailers and stands. The Office of State Fire Marshal has issued more than 810 retail fireworks permits, and 185 display permits.

Oregon law forbids possession, use or sale of fireworks that fly, explode or travel more than six feet on the ground or 12 inches in the air. Bottle rockets, Roman candles, and firecrackers are ILLEGAL in Oregon.

All fireworks are prohibited on all Oregon beaches, in parks, and campgrounds.

Illegal fireworks can be expensive. Under Oregon law, officials may seize illegal fireworks and fine offenders up to \$500 per violation for possession of illegal fireworks and endangering life and property. Offenders may also be arrested. Any fireworks causing damage, or misuse of fireworks carries a liability for the offender, who may be required to pay for resulting fire or other damage. Parents are

liable for fireworks-caused damage by their children. Costs may include assessed fines as well as the cost of suppressing fireworks-caused fires.

## Damon Sworn-in As Clackamas County Commissioner June 15

Jamie Damon, a 15-year resident of Eagle Creek, was ceremonially sworn-in as a Clackamas County Commissioner on Wednesday, June 15. She began her new role June 1 after being appointed last month to the Position 4 seat vacated by Charlotte Lehan.

Damon takes over the seat previously held by Lehan, who was appointed Board Chair in March following the resignation of Lynn Peterson, who is now serving as a senior aide to Governor John Kitzhaber. The swearing-in ceremony took place at 4:30 p.m. in the Board of County Commissioners 4th floor hearing room, 2051 Kaen Road, Oregon City.

Damon had previously served as collaborative systems director for the National Policy Consensus Center at Portland State University. Sixty-three candidates applied for the vacancy during a recruitment that closed April 13.

## CCHS Wins \$25,000 Grant To Repair Stevens Crawford House Roof

The Oregon City-Metro Enhancement Grant Committee has approved a \$25,000 Clackamas County Historical (CCHS) application May 24th to fund most of a \$38,583 project to repair the roof of the historic 1908 Stevens Crawford House (SCH) at 603 Sixth St., in Oregon City.

The Four-Square-style, early 20th-century home has a hipped roof featuring the original concealed, wood-frame gutters lined with galvanized steel. The gutters are common on homes built in the era and were designed to last 100 years. The SCH gutters are 103 years old and failing, causing damage to the soffits and eaves. Some downspouts also are disconnected or clogged.

Temporary roof repair work was completed on SCH by Portland-based Craftsman Design and Renovation LLC over the 2010-2011 winter. By agreeing to fund the project to fix the roof and gutters, the Oregon City-Metro Enhancement Grant Committee is prolonging the life of this historic home.

The Stevens family continually occupied the Stevens Crawford House until 1968 when Mertie Stevens bequeathed it and most of its original furnishings to CCHS. It is a rare and excellent example of a typical home owned by a historically prominent family in the emerging cultural society of Oregon during the transition from 19th- to 20th-century lifestyles and values.

SCH is operated for CCHS by a dedicated group of volunteers who open the house to the public noon to 4 p.m. Thursdays, Fridays and Saturdays, for a \$5 admission. Additionally, the home is the site of exhibits (The current *Hats Off!* exhibit features more than 100 historic hats in the SCH collection – some of which date to the 1700s), an annual community plant sale every April, a benefit tea in May and a community-wide, free Christmas open house in December.

Project time lines are to be determined. CCHS intends to underwrite most of the outstanding balance of the project with a \$10,000 gift provided by an anonymous benefactor. The roof project is Phase I of a two-part repair project, totaling \$58,000, which also includes painting the home's exte-

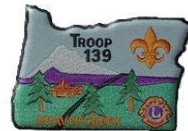

This is the second grant won by CCHS in as many months. The organization also was awarded an \$11,000 grant from the Oregon City Civic Improvement Trust in March to develop an exhibit on 20th-century, Oregon City photographer Ralph Eddy.

## State Fines Mega Life And Health \$40,000 - Insurer Refused To Pay Claims Without Investigation

The Department of Consumer and Business Services recently fined The MEGA Life and Health Insurance Company \$40,000 for improperly denying 877 claims for breast exams and Pap smears.

Oregon law requires that both exams be covered. In fact, MEGA had issued a group health insurance policy to the National Association for the Self-Employed (NASE), which provided these mandated benefits to Oregon members of NASE.

However, the MEGA policy also excluded benefits for "any routine physical examination or any other expenses that are not for the treatment of a specific injury or sickness." MEGA denied the claims because routine physical exams were excluded. Oregon law prohibits an insurance company from refusing to pay claims without conducting a reasonable investigation.

"Oregon has decided that breast exams and Pap smears are important elements of a woman's routine

health care, and that's why they must be included in insurance policies," Insurance Division Administrator Teresa Miller said.

"Fortunately, a consumer who was denied coverage brought this to our attention and our investigation was able to help many others," Miller said.

In addition to the fine, MEGA reimbursed its members whose claims were improperly denied.

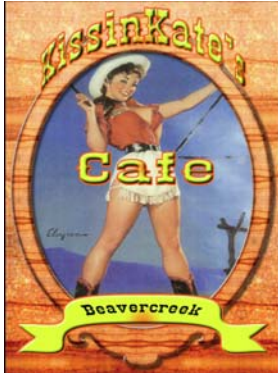

## Do We Have Your Money?

*New online process offers easy search*

More than two million individuals, businesses and organizations have lost track of money - a lot of it. Nearly \$400 million is available for claim by the owners or their heirs, and it just got easier to find.

Oregon's Department of State Lands (DSL) houses the State's Unclaimed Property Program, and has recently launched an online claim service to make it easier and faster for citizens to search for and claim their lost money.

Could you have misplaced a check or lost track of a bank account? If so, your money may be waiting for you to claim. Simply check for your name on the unclaimed property website: <https://oregonup.us>.

The new service also includes details on each listing and a tracking feature to help claimants monitor the status of their claim.

"It's so easy now to search for your name, and with two million owners reported, there is a high likelihood of finding money due to you or a relative," said the program's manager, Patrick Tate. While a few large amounts are reported, most are between \$50 and \$500, said Tate.

Reported assets include inactive bank accounts, stocks,

mutual funds, refunds and payroll checks. Businesses and organizations are required by law to send all unclaimed assets to DSL after a specific period of time - generally three years - and after trying to find owners. Once reported, there is no time limit for the owner to file their claim.

Unclaimed property is held for claim by owners in the Common School Fund, a trust fund established at statehood to benefit Oregon's public schools, and administered by DSL. Earnings from the fund are distributed twice a year by the Oregon Department of Education; in 2010, \$50.5 million was sent to Oregon's 197 public school districts.

In 2010, DSL returned \$18 million to owners. Check for your name today, and check back often, as new information is added to the website regularly.

The State Land Board consists of Governor John Kitzhaber, Secretary of State Kate Brown and State Treasurer Ted Wheeler. The Department of State Lands administers diverse natural and fiscal resources. Many of the resources generate revenue for the Common School Fund, such as state-owned rangelands and timberlands, waterway leases, estates for which no will and heirs exist, and unclaimed property. Twice a year, the agency distributes fund investment earnings to support K-12 public schools. The agency also administers Oregon's Removal-Fill Law, which requires people removing or filling certain amounts of material in waters of the State to obtain a permit.

What does DSL do to return the money to the rightful owner?

How far does the information go back? DSL has records going back to the 1970s. There is no time limit to recover funds.

How long does it take to get money? Simple claims are usually processed within 30 days after receipt of the claim form. For more complicated claims or when claim volumes are high, it can take up to 90 days.

## Oregon City Police Need Help Solving Animal Mutilation Cases

Oregon City Police have taken two reports this month that we believe are connected. In both cases, citizens found mutilated cats and reported them to the police.

On Saturday, June 11, 2011, remains of a dead cat were found in the St. Johns Cemetery, located at 451 Warner Street, in Oregon City. Only half of the body was found, the head and front legs of the cat were missing. The skin of the cat had been peeled down toward the tail.

On Thursday, June 23, 2011, another mutilated cat was found at Hillendale Park, located at 19260 Clairmont Way, in Oregon City. The remains of this cat were the same as the cat that was reported on June 11. The head and upper body were gone and the cat had been skinned.

Police believe the cases are connected specifically because the nature of the mutilation is identical. We would like this information to reach citizens in hope that they

have either seen somebody approaching cats in their neighborhoods or possibly some other suspicious behavior. It is also possible that friends/family of the suspect would have seen some behaviors that would give us information to use in our investigation.

Both cats appear to have been adult cats, dark grey in color with white socks. The hair of both cats was medium in length. We would also like to know if anybody is missing a cat that matches that description.

The relevant charge here would be Aggravated Animal Abuse I (O.R.S. 167.322), a Class C Felony. A person commits this crime by maliciously killing and/or intentionally torturing an animal. Outside the crime itself, the nature of the criminal act is very alarming.

The Oregon City Police Department along with Meow Village have set up a reward fund of \$200 for information leading to the arrest and conviction of the person or persons responsible for the mutilation

In addition the Meow Village cat rescue has set up an account with US Bank for anyone who wants to donate towards the reward. Contributions to the reward fund can be made at any US Bank in the name of "Reward for Mutilated Cat" fund. Persons can also contribute by calling Meow Village reward organizer Richard Grow at (503) 939-1466.

## Type O Negative Blood Supply Drops To Critically Low Levels

The supply of type O negative blood at the American Red Cross has dropped to critically low levels. Type O negative blood is always in high demand because it can be transfused to patients with any blood type, especially in emergency situations. Type O negative donors are needed now to help prevent the type O negative blood supply from declining further.

While all blood types are needed during the summer months, the Red Cross urges eligible donors with O negative, B negative, and A negative type blood to make appointments in the upcoming days to help restore the blood supply.

"The American Red Cross is offering convenient blood drive hours and reaching out to eligible blood donors, sponsors and community leaders to ask them to help recruit

type O negative blood donations to help meet the needs of patients in our community," says Daphne Mathew, spokesperson for the American Red Cross Pacific Northwest Blood Services Region.

A shortage of type O negative blood often occurs during the summer months when fewer donors are giving because of summer vacations and schools on summer break hosting fewer drives. Every two seconds, someone in the United States needs blood. The Red Cross Pacific Northwest Blood Services Region provides lifesaving blood to more than 80 hospitals and must have nearly 1,100 people give blood and platelets each weekday to meet hospital demand. Accident victims, as well as patients with cancer, sickle cell disease, blood disorders and other illnesses receive lifesaving transfusions every day. There is no substitute for blood and volunteer donors are the only source.

Individuals who are 17 years of age (16 with parental permission in some states), meet weight and height requirements (110 pounds or more, depending on their height) and are in generally good health may be eligible to give blood. Please bring your Red Cross blood donor card or other form of positive ID when you come to donate.

She shared information on climate change from the workshop given by Professor Christopher Thomas of Oregon State University.

Between 1920 and 2000 our temperature has gone up 2 to 4 degrees and along with it rainfall has gone up. This leads to an increase in evaporation that in turn causes stronger storms that drop more rain and snow. The temp change can also cause

droughts that in turn affect food production as well as the water content of snow packs. Why is this so important? Because it is happening worldwide.

Many tips were given on how to save energy in your home which in turn saves you money. The NW Power Council expects it will take 85% conservation from the public to avoid having to build more power plants.

To find out where your power is going you can check out an instrument at your local library named "Kill A Watt" meter. It can tell you how much power your plugged in items are using. A kWh = 1,000 watts for one hour.

## Clackamas County Community Solutions Receives \$500,000 Grant

The U.S. Department of Labor has announced that Community Solutions for Clackamas County (CSCC) will receive a grant for \$500,000 to continue its successful workforce investment program for veterans. The grant is part of a national workforce program designed to support and continue successful job training and placement efforts that focus on getting veterans to work. Grants total \$9 million nationwide and will serve over 4,000 veterans. The CSCC grant serves veterans residing in Clackamas, Multnomah, Washington, Marion, Polk and Yamhill counties. CSCC serves as the grant administrator with contracted services provided by Employment Department Veteran's Representatives and Laborer's Community Service Agency.

"During these challenging economic times, Oregon's returning veterans in particular are struggling to find jobs," said Congressman Earl Blumenauer. "This grant will ensure that the highly successful Community Solutions program can continue to help our veterans find employment."

Last year, the CSCC grant served 253 Veterans from Clackamas and 5 other counties. Of those served, 23% were disabled; 49% were economically disadvantaged and 31% were receiving public assistance. 79% of the en-

rollees received some type of civilian job skills training or retraining. The average wage of veterans securing employment was \$17.80/hr. It is anticipated that the grant will provide support and placement services for approximately 250 veterans with 80% going through jobs skills training over the coming year.

"This grant will enable Clackamas County to continue programs to find jobs for our veterans," said Clackamas County Commissioner Jim Bernard. "The Board of Commissioners is very proud of our veterans, and of the good work of our Community Solutions team."

Grant funds from this program are targeted to programs that provide training for veterans who are interested in

"green" jobs that are currently available in the marketplace or expected to be soon. Such jobs include those related to energy efficiency and renewable energy, modern electric power development and clean vehicles.

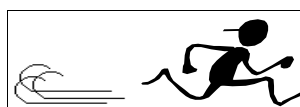
