## Complete Communities Meeting Held September 12th

The "Complete Communities" meeting was held at the Beaver Creek Grade School on Tuesday, September 12th at 7:00 p.m.

This is the first of several meetings which will be held in the Beaver Creek area.

It was surprising to see that only 75 residents of the Beaver Creek area showed up for this meeting, as the County sent out approximately 2,700 notices to the citizenry. Quite a few individuals said that they never received a notice and only knew about it from friends.

Even though the turnout was low (the County was hoping for at least 150 participants) the consensus was that the people of Beaver Creek want local control as well as the rural flavor to remain.

I was not able to get a summary of the meeting in order to print here, but was told that by the time the November "Bulletin" is published it will be available. So stay posted. The people who did attend the meeting were given the opportunity to let the County know whether or not they would like to attend the "Community Congress" to be held on October 28, 2000 at the Oregon City High School, 1306 12th St., Oregon City. The "Congress" will be from 8:30 am - 2:30 pm.

Randy Bruegman, Chief of Clackamas County Fire District #1, explained the bond issue that will be on the November ballot. It will be for 15 years and be .09 / \$1,000.00 of assessed evaluation. This means a house assessed at \$100,000.00 would pay \$9.00 / year.

Other political groups were given 5 minutes each to explain their ballot measures.

A written application is required to adopt with a waiting period of 24 hours between the application and picking up your new friend. The park is starting to look very nice with all the flowers and barkdust, they even got the handicapped parking sign mounted on the pole.


The kids are doing a great job on the project with a little help from the Boosters. This last Saturday, Geoff Reynolds was hard at work with the youth, with the help of a friend.

### Community Emergency Response Team (CERT) team members are being recruited by Clackamas County Fire District No. 1.

The Fire District is recruiting individuals who are willing to serve on a neighborhood CERT. The teams assist the Fire District and their neighborhoods during major or catastrophic events. Earthquakes, floods, building collapse and winter storms can overwhelm local emergency responders. Properly trained and equipped community volunteers can assist and aid their neighbors during incidents such as those listed above. The Fire District provides a 30-hour training program designed around the Federal Emergency Management Agency (FEMA) guidelines, and is looking for individuals willing to take the training.

The training and equipping of CERT volunteers is "customized" for different regions. In the urban or north areas of the Fire District, many residents do not own or have access to basic tools like shovels, rakes and sledge hammers. Without some of these tools, clearing debris left over from a flood, building collapse or windstorm is almost impossible. In the Beavercreek area it is important that residents have a cache of food and water since the area would be among the last to have power restored during a catastrophic event. The CERT training is designed to teach the team members skills that they can use to help themselves and their neighbors.

Fire fighter-paramedic Fred Charlton coordinates the Fire District's CERT activities and is taking applications for a training class scheduled to begin in early January. More information on CERT can be obtained by calling the Fire District at 503-655-8542 ext. 300. You will be asked to leave your name and telephone number. Fred will contact you as soon as possible.

### Backyard Burning Starts October 1st and Ends December 15th

October 1st begins backyard burning again, but is over on December 15th. Burning before 8:00 a.m. or outside of the allowed hours is prohibited by D.E.Q.


Call 503-632-0211 each day you plan to burn to determine if it is a burn day and to determine the approved burning hours. **Fires must be out two hours before sunset unless otherwise specified!**

Only materials such as yard debris and tree trimmings may be burned. See the brochure available from the fire department for a list of "Prohibited Materials" that cannot be burned.

**NOTE:** Some areas of Clackamas County Fire District #1 are within areas where D.E.Q. does not allow **any** burning. If you are not sure about your location, check with your local CCFD #1 fire station.

*Burning in violation of the rules is both a Uniform Fire Code violation and a violation of D.E.Q. Air Pollution Regulations.*

The Fire Chief or Fire Marshall will refer any burning violation to D.E.Q. Violation may result in a fine of up to \$10,000.00 per day from D.E.Q. So be careful! Be safe!

**10 Digit Dialing Starts October 1st**

Well, whether we are ready or not, the reprieve is over and starting October 1st we have to start dialing 10 digits to call anywhere.

What does this mean? Well, if you use an autodialer to call everyone you call often, you will have to look up their numbers all over again and add the 503 area code to the number or you will not be able to talk to them. Also, if you access the internet, you will have to reprogram the dialer to add the area code to the number or heaven forbid... you will be unable to surf or get mail!

If you have a security system it will also have to be reprogrammed to dial the area code or it won't be able to call for help. Be proactive, not reactive and start the program today.

**"Who left that big dumpster there?"**

Many people would love to know why that big dumpster for newspaper is sitting at the "Corner Park."

The big Lions Club emblem on the side should be a dead give-away. What do we do with all of your old newspapers? Well, we recycle them! Actually, the importance of the recycling bin is that it provides us with a fairly good income from selling the newsprint, and we use that to buy glasses and hearing aids for kids, as well as give out scholarships at local high schools to Clackamas Community College. Many thanks to all who drop off their old newspapers to help us make this happen.

Could we ask a favor? The price we get for each load depends on how 'clean' the load is - how little there is of extra junk. The recycling bin should not have magazines, boxes, grocery bags, etc. - even though they are recyclable. It is for newsprint only. Actually, we Lions (with occasional help from the Scouts) have to climb in the recycling bin regularly and remove all of those items, or we get paid less per load.

Also, there is somebody who ever so often drops in some garbage or a bag of ashes. That's just gross. Please, keep our bin for newsprint only, and remember that it helps our kids. Thank you. *Submitted by Robb Peck, Beavercreek Lions Secretary*

**From the Desk of our State Representative, Kurt Schrader**

Dear Beavercreek Citizens:

As your State Representative for the past two legislative sessions I have done my utmost to serve you, the citizens of District 23. As a fiscally conservative small businessman, I have continued to be a moderate voice for solving some of Oregon's most pressing issues, and have continued to hold government agencies, such as ODOT, accountable for their spending and management practices. In addition to advocating for a more businesslike approach to state government, I worked across party lines to seek better ways to fund our K-12 education system, and have continued my work to directly involve citizens in our government and our land-use processes. As a veterinarian, farmer, and small businessman I have consistently supported viable, small businesses and equal economic opportunities for all.



### Making Room for the Future

New communications technology has become a part of everyday life in Oregon - and every time we get a new phone line, fax machine, computer modem, wireless phone or pager, it requires a new telephone number.

To meet this growing demand, Oregon is adding a new 971 area code which will overlay the 503 area. As a result, it will be necessary to dial ten digits because of the duplication of seven digit numbers between the 503 and 971 area codes. Dialing ten digits just means you must add the area code before dialing the seven digit number.

The new 971 area code overlays the same boundaries as the current 503 code, except for coastal communities located within the exchanges of Warrenton, Astoria, Knappa, Westport, Seaside, Jewell, Canon Beach, Nehalem, Rockaway Beach, Garibaldi, Bay City, Tillamook, Pacific City, Cloverdale/Hebo and Beaver. These communities will retain seven digit local dialing at this time.

Permissive dialing is already in effect, so callers in the 503 and new 971 area codes should begin dialing ten digit numbers for all local calls. After the mandatory date of October 1, 2000, all local calls will be correctly routed only when the full ten digit numbers are dialed. It makes no difference whether your call is to the same area code.

Do not dial a "1" or "0" before the area code when dialing a local call. Dialing a "1" is needed when placing a long-distance call; dialing a "0" indicates the need for operator assistance. In both cases, you could incur charges for the call. Remember, if your call was local before, it will remain a local call.

How will ten digit dialing effect your home and business service? Use the following list as a guide to prepare.

Start using ten digit numbers for all local calls.

Automatic dialing, speed dialing and call forwarding features need to have local numbers reprogrammed.

Internet dial-up connections may need to be reprogrammed or upgraded.

Preprinted items such as stationary and checks should be updated to include all ten digits.

If appropriate, notify your alarm company of your ten digit number.

Be sure everyone in your household knows your full ten digit number and understands how to place local calls using the ten digit pattern. Pay particular attention to the needs of children, the disabled and the elderly.

Inform employees and customers of the need for ten-digit dialing.

Remind customers of the potential need to make changes to their equipment.

Test all telephone equipment.

Things ten-digit dialing WON'T change:

Local calling areas.

Your seven digit phone number.

9-1-1 emergency calls, or calls to 800, 877, 888, 900 numbers.

Directory assistance.

Cellular and PCS services, pagers & other wireless communications do not need to be reprogrammed.

The Fine Print:

Because ten-digit dialing and area code modifications are the result of normal growth in Oregon and have been mandated by the OregonPUC, <http://www.puc.state.or.us>, costs incurred for updating equipment and revising printed materials are the responsibility of individual customers.

After October 1, 2000, Oregon is scheduled to begin assigning prefixes to the new 971 area code. Existing 503 customers will retain their phone number and the 503 area code; new customers or existing customers requiring an additional line may be assigned numbers in the new 971 area code.

After working with your equipment vendor, if you still experience difficulty dialing ten-digit local numbers or the new 971 area code after October 1, 2000, call your telephone system vendor.

After October 1, 2000, if you should place a local call within the 503/971 area by dialing seven digits, a recording will ask you to re-dial using a ten digit number. *Submitted by Beaver Creek Cooperative Telephone Company*
