Beavercreek/Clarkes Area**

Clackamas County and Asphaltic Paving Company will begin a five-road paving project between Oregon City and Molalla at the end of August. The roads include Beavercreek, Union Mills, Buckner Creek, Larkin and Gard. The project is scheduled to be completed near the end of September.

The project includes the paving of 17 miles of roadway, the recycling of pavement on Gard Road and some bridgework. Traffic will be impacted and delays should be expected.

Clackamas County Dog Control Expands Adoption Hours

Clackamas County Dog Control has expanded its hours of operation during the week and beginning August 4 will be open on Saturdays.

The new hours of operation (Saturday hours begin Aug. 4) at Dog Control are as follows:

Office: Monday through Friday from 8 a.m. to 6 p.m. Saturday from 9:00 a.m. to 5:30 p.m. (for the sale of dog licenses and pick up of lost dogs only.)

kennel: Monday through Friday from 7:30 a.m. to 6:00 p.m. to locate and reclaim lost dogs and from 11:00 a.m. to 5:00 p.m. for adoption and viewing. Saturday from 11:00 a.m. to 5:00 p.m. for adoption, viewing and reclaiming dogs.

History of Beavercreek Mutual Phone Company

About March of 1904, a Mr. Thomas who owned a mutual telephone company in Molalla came to a Beavercreek Grange meeting and asked how the members felt about forming a telephone company. A motion was made to form a committee to canvas the area to see if phone service was wanted. Records are unclear of the minutes kept until late in 1904. No progress was made in the formation of the phone company until January 22, 1905.

The first switchboard was installed in Henry Hughes' store which is now known as Beavercreek Grocery. In 1908, Mr. Hughes made a contract for \$2.00 per month for running the switchboard and a contract for \$300.00 for running the switchboard for 5 years. After this Mr. Hughes sold out to a Mr. Snyder for one year with the option to extend the contract to five years. There are no real dates and records for this period of time.

On January 10, 1913, the Beavercreek Hall Committee, which owned the Beavercreek/Central Grange, made a motion to buy 1/4 acre of ground on which to build a phone company and charge each member \$1.50. This motion was defeated and did not come up again until December 14, 1914, when the committee again made a motion to buy 1/4 acre for \$67.50 next to the blacksmith shop which was across the street from the present fire hall. A two story building was built with a meeting hall upstairs and the telephone company downstairs. The operator lived in the building with the switchboard. Annual meetings were held in the meeting hall upstairs. *Here ends the history of Beavercreek Mutual Telephone Co. Next month I'll start the history of Beaver Creek Cooperative Telephone Co. Clackamas County Cable Needs Assessment Public Meetings

Clackamas County is re-negotiating its cable system franchise with Beaver Creek Cooperative Telephone Company, one of the cable systems that provides service in unincorporated areas of the County. Federal law allows City and County government to negotiate for public, educational, and government (PEG) programming, and other services that address unique and demonstrable community needs.

Renewal of a cable franchise provides a once-in-a-decade opportunity for local communities to influence the services available via their cable communications system. The cable system has the potential to offer much more than commercial TV channels and entertainment.

Many communities receive services such as locally-originated programming, education access and programming, televised public meetings and "town halls," Internet access, local government access and information, non-English programming, emergency communication services, and institutional networks. It is important for citizens to evaluate the potential benefits and costs of such services to their communities.

The County is inviting interested citizens to provide insight about community needs and potential uses of the system. The County will be gathering information from the community at the meetings of three local Community Planning Organizations. The agenda will include the community's needs for cable TV and other telecommunications services.

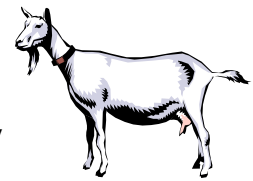

Hate Waste? Sign Up To Become A Master Recycler in Clackamas County

Do you hate to see anything go to waste? Do you love to share knowledge with others? Do you want to make a difference in the world? If so, you may have what it takes to become a Master Recycler.

Clackamas County will host the next Oregon State University Extension Service Master Recycler course, set to begin Tuesday, Oct. 9 at 6:30 p.m. in the County's Sunnybrook Service Center, 9101 SE Sunnybrook Boulevard. The popular eight-week course, which includes two field trips, provides 30 hours of instruction in topics such as waste reduction, recycling processes, alternatives to hazardous household products and composting.

Once certified, course graduates put their skills to work to help others learn the three R's to reduce the amount of solid waste generated, reuse material for the purpose for which it was intended and recycle material that cannot be reused. Master Recyclers volunteer to

staff information booths at community events, make presentations and work on special projects.

The \$50 course fee includes materials. Scholarships are available. Advance registration for the fall course is required by Oct. 2. Information and applications are available by calling OSU Extension Service Agent Megan Cogswell at 503-725-2035.

Master Recyclers is an OSU Extension Service program supported by Metro, the City of Portland, Clackamas County Recycling Partnership, Recycling Advocates and the Department of Environmental Quality. For more information call Susan Terry at 503-353-4461.

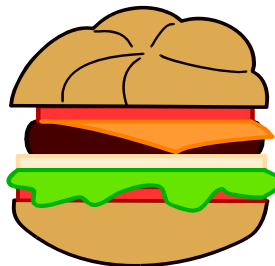
